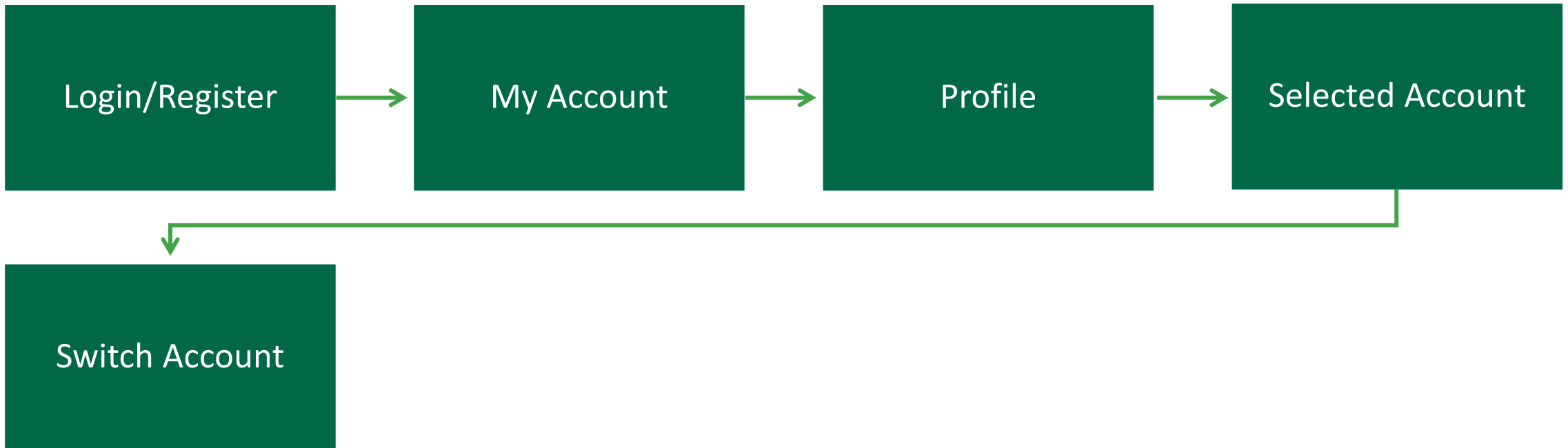

Your organization may have several accounts with Neogen. To purchase and view account information for another account within your organization, use our Switch Account feature under My Account.




# Navigate to Switch Account



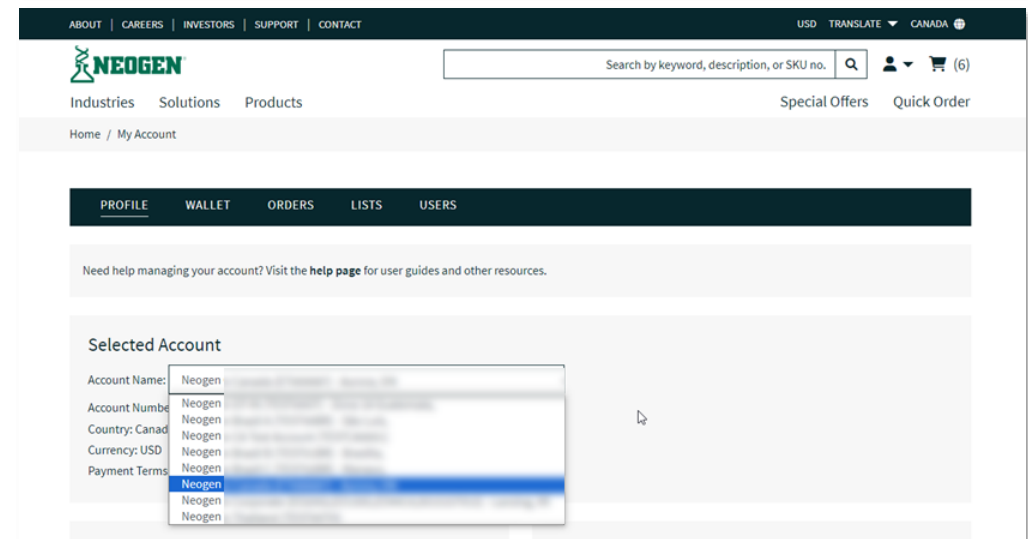
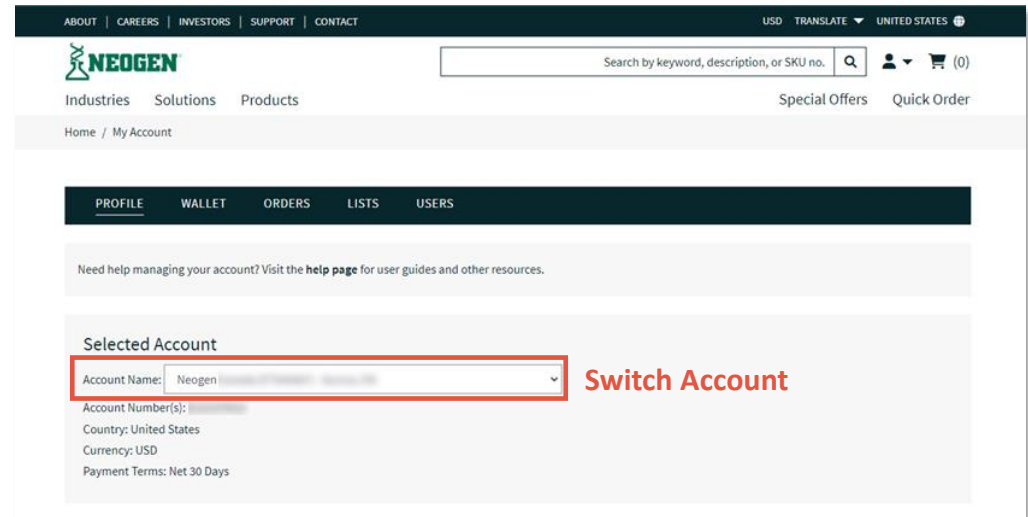
The Profile tab displays the account selected and associated account information.
